The "Broken Windows Theory" (also called "Broken window effect") is one of the classical theory of criminal psychology, first appeared in the famous article "visible and invisible" written by Claude Frédéric Bastiat, who is the nineteenth Century French classical liberal theorist, economist, and the French Legislative Council member, he is also considered as the "Creator" of the "Broken Windows Theory". The original meaning of the theory generally refers to "harm is beneficial", meaning roughly refers to "harm beneficial" [4], for economic and social development has been pushed to promote economic development by damage.

Under the influence of Bastiat's theory, an experiment was done by Philip Zimbardo, Dr. of psychology of Stanford University the United States, in 1969. He parked the same two cars in the middle class community and the poorer civilian communities, and opened the ceiling and removed the license plate which parked in the civilian community. As a result, the car without license was stolen the same day. But the other

one, was still in that place for one week, intact, like nobody's paying attention to. Later, Zimbardo smashed a hole on this car's windows, the car disappeared in a few hours [5].

Based on Dr. Zimbardo's experiment, The "broken window effect" theory was proposed by James Q. Wilson, American political scientist, and George L. Kelling, American criminologist, in 1982. The theory holds that if a bad phenomenon in the environment is allowed, it will induce people to emulate, or even become aggravated.

The Destructive Cults Poison Youngsters by using the "Broken Window Theory"

The destructive cults are actually famous for their lies. They call themselves religion. They frequently use the cloak of religion, by means of Internet technology advantages, seize the youth judgement weakness, with the so-called "eyeball" false news to confuse the public, especially young netizens brought attention to induce them to be stuck on the destructive cult. The "Broken Window Theory" gives destructive cults more opportunities, which caused great harm to society and personal safety.

In reality, although countries have adopted corresponding measures to prevent and control the destructive cults, but the destructive cults are still eroding and poisoning many believers and adolescents, with their highly confusing, coupled with the Internet, the rapid and spread of identity hidden, and some other features.

Cases Study

There are still many destructive cult organizations in the world today. Hundreds of millions of innocent people suffered from it, especially young people who went astray.

For example, a Russian former fitness trainer Sergey Kirienko, founded a strange sect, admitted as a spiritual teacher, recruited dozens of women and forced them to do anything to please the tutor. Dozens of women were his concubines, distinguished by him, so-called "highest species", this type of brainwashing freak is actually the "broken window effect" results. The cult mentor has been accused of forcing followers to take part in illegal crimes in the name of God, being detained in Bulgaria and extradited to Moscow [6].

Another example, the "Falun Gong", which is still rampant all over the world, is the largest and most abundant using Internet among destructive cults in the world. It uses much more Internet than other cults. "Falun Gong" establishs the "Epoch Times" "FaLun DaFa Minghui" nets as the representatives of the cult websites, in more than 25 countries and regions. There are even more than 20 languages in use on those websites, running dozens of network columns, such as

news, international, science and technology, Taiwan, mainland China, Hongkong, comments, social, entertainment, sports, finance, the United States, life, immigration, health, fashion, delicacy, workplace, tourism, real estate, automobile, culture, art, perception, exploration, literature, history, education, industry and commerce, blog, video, etc. In fact, "Falun Gong" has eroded and poisoned the Internet users all over the world, especially for the growth of teenagers. Its online propaganda mostly attracts Internet users by grapevine news and lace news, in particular, a lot of so-called "Falun Gong anti persecution", "hundred years truth of the Communist Party", "China's current situation fully analysis" and other false news. Just one example, the "falsified organ" and "cruel torture", which are widely publicized on the "Falun Gong" website, are forgery rumors. In May 2013, the Qingdao Public Security Bureau of Shandong province of China, broke a typical case. The 16 members of the "Falun Gong" led by Lu Xueqin tried to demonstrate in real life. They attempted to forge a picture of the torture and persecution of the "Falun Gong" organizations in prison in the form of real human simulation in order to distort facts, spread rumors and blacken the image of China. They used red pigments, ketchup, coke and other "plasma", sticks, boards, ropes, tape, toothbrushes, cameras, computers and other equipment for shooting, making pictures, and listed 25 "torture" lists to be made on two A4 sheets, and marked the "torture" that had been processed. Some people used red liquid on others, some lied on the ground to play the tortured person, some held high huddling to play the attacker, some held down the attacker to play the accomplice, and some took the camera on the side to make photos [7]. "Falun Gong"'s so-called "living torture" is so processed. "Falun Gong"'s highly concealed and provocative distorted reports misled many people, especially young people, to form a bad influence.

DISCUSSION AND CONCLUSION

Some Consensus of Scholars in Different Countries and Periods of History

Science and justice are amenable to the wheel of history. Liang Qichao, a famous thinker and educator in Qing Dynasty China, pointed out in his book "moral education" that science is not only used to seek knowledge, but also to be a tool for personal accomplishment.
